

PRIVACY NOTICE FOR THE PROCESSING OF PERSONAL DATA

TONE FLOWERS S.A.S., responsible for the treatment of personal data provided by its employees, suppliers, third parties and other interested parties, which are collected for control purposes, commercial management, compliance with legal provisions and other activities carried out in the development of our corporate purpose.

For TONE FLOWERS, the most important is our workers, suppliers and customers, for this reason as responsible for the processing of personal data, we apply procedures that protect your personal data, through the use and maintenance of technical, physical and administrative security measures. In order to prevent unauthorized third parties from having access to them, thus complying with the provisions of Law 1581 of 2012, regulated by Decree 1377 of 2013, and our personal data processing policy: PR 038.

Therefore, we inform you that in compliance with our Personal Data Processing Policy, the personal data that you have provided will be treated securely within the protection principles defined in law 1581 of 2012. The rights that you have as owner of the information are: know, update, rectify and request deletion of your personal data (1), request proof of the authorization granted, be informed about the use given to your personal data; file complaints for infractions as provided in the personal data standard; revoke the granted authorization and consult free of charge the previously authorized personal data.

The identity or data of another person can not be used in the provision of information. At all times, you can keep in mind that you can only include data to your own identity, which must be adequate, relevant, current and true. The person is solely responsible for any damage that may cause third parties or the Company for the use of personal data of another person, or when referring to their own data, make the information incorrect, false, outdated, inappropriate or irrelevant. It is presumed that the veracity of the information provided by the owner, therefore did not assume the obligation of veracity, validity, sufficiency and authenticity of the data provided. Consequently, we will not assume responsibility for damages of any nature that may arise from the lack of veracity, validity, sufficiency or authenticity of the information, including damages or losses that may be due to a homonymy or identity theft. TONE FLOWERS S.A.S., may in any case verify the accuracy of the personal data provided, confirmed when deemed necessary, going to public entities, specialized companies or information centers. The information that the Company receives from these entities is treated confidentially.

The management that TONE FLOWERS SAS, will give in relation to data and information found in its databases or physical files will be limited to the use that it requires to advance its corporate purpose and / or to comply with legal provisions that regulate the exercise of their activities.
